

**AN ORDINANCE AMENDING THE KILL DEVIL HILLS TOWN CODE,
CHAPTER 96, SEASIDE REGULATIONS**

BE IT ORDAINED by the Board of Commissioners of the Town of Kill Devil Hills, North Carolina, that Chapter 96, Seaside Regulations, of the Kill Devil Hills Code of Ordinances, shall be amended by adding the underlined language and deleting the following ~~stricken~~ language to the sections identified below, as follows:

CHAPTER 96: SEASIDE REGULATIONS

§ 96.15 BEACH ACCESSES.

(A) Parking.

- (1) Parking prohibited between 12:00 a.m. and 6:00 4:00 a.m. at beach access parking lots and areas. No vehicle or trailer shall be parked and left unattended at any beach access parking lot or area within the Town of Kill Devil Hills between 12:00 a.m. and 6:00 4:00 a.m., unless vehicle or trailer displays valid Town-issued permit.
- (2) Parking Permit required. A parking permit may be obtained during normal business hours from a designated Town department. Permits are issued free of charge to property owners and/or residents in the town upon verification of two forms of identification:
- (a) Valid government-issued photo identification (such as a driver's license, passport, or military identification), AND
 - (b) Proof establishing residency or property ownership within the town (including current tax record, long-term lease [12 months or more], utility bill, or voter registration card).

- (c) Number of permits issued. A maximum of two (2) parking permits will be issued for the owner of each property or one (1) permit will be issued for each resident.
- (d) Placement of parking permit. Once issued, the parking permit must be affixed to the lower left, driver's side rear window.

This amendment to Chapter 96, Seaside Regulations, shall be in full force and effect from and after the 12th day of May, 2025. Adopted and approved by the Board of Commissioners of the Town of Kill Devil Hills at a regular meeting held on the 12th day of May, 2025, by a vote of 4 in favor and 1 opposed.
